7. An amusement license is required for the carnival rides and games and a temporary liquor license is required for the alcoholic beverages provided on the premises. Please contact the Licensing Division at 314-615-4217.
8. If food is to be served, the operator must complete a special event food application prior to the event. You may contact the Department of Health at 314-615-4027. If chemical portable sanitation units are to be used, an application for chemical toilet (porta-potties) must be completed and submitted to the Department of Health, 314-615-8900.

Please be informed that an inspection of this event will occur within 24 hours prior to the opening of the event.
