Shall the Metropolitan St. Louis Sewer District (MSD) impose a Stormwater Operations and Maintenance property tax upon all real and tangible personal property within the district at a rate of not more than Ten Cents (\$0.10) per One Hundred Dollars (\$100.00) assessed valuation for the purpose of providing revenue for the operations of the district stormwater utility, including stormwater system operation and maintenance, rehabilitation and limited construction of infrastructure and other capital improvements, and an operating reserve? If this proposition is approved, MSD will repeal (a) the existing stormwater operations and maintenance property tax of approximately Seven Cents (\$0.07) per One Hundred Dollars (\$100.00) assessed valuation that is imposed on property within the original boundaries of MSD, as defined in the MSD Charter, and within the annexed areas described in MSD Ordinance No. 3753, and (b) the existing monthly 24-Cent or 18-Cent stormwater service charge that is imposed on each MSD customer account. As a result, a uniform districtwide stormwater revenue system for operations, maintenance, and limited capital improvements will be in place.
