RULES FOR PARTICIPATION

Open to artists over the age of 18. Artists must be present for the entire show. No representatives are allowed. Positive I.D. may be required. Artist may show only in categories approved by the photo jury.

All work must be designed and executed by the accepted artist. Ceramics-no commercial molds; Jewelry-no commercial casts, molds, beads, or work of production studios; Photography-all prints must be from the artist's original negatives, processed by the artist or under their direct supervision. All two-dimensional work must be properly framed. All unframed work must be contained in portfolios. Commercial reproductions of original artwork cannot constitute more than 50% of the displayed work excluding the portfolio. **Only artists accepted in Jewelry Category may display or sell jewelry.**

Disclaimer: St Louis County Parks reserves the right to select, via jury process, the show participants. In addition to the jury process, St Louis County Parks reserves the right to reject any artist for good cause. Good cause includes, but is not limited to, inappropriate behavior on the part of the artist, inability of the artist to comply with the rules and regulations of the show, misrepresentation of work through photos, and presentation of work which falls below the standards of the St Louis County Parks.



EXHIBITING FEES

Applicants **must send two (2) checks**; one in the amount of \$85.00 entry fee for a regular booth space and \$100 for a space inside a historic home, the other a \$15.00 nonrefundable jury fee. Artists applying in multiple categories must submit a set of (4) photos for each category, booth photo, or a CD with your photos and a \$15.00 jury fee per category. **Make checks or money orders payable to: St Louis County Parks.** Please print the artists name on the check. The receipt of your application will be considered a commitment to the show. There will be **no refund** if you cancel after April 15, 2012.

APPLICATIONS DUE BY APRIL 10, 2012.

NONE WILL BE CONSIDERED AFTER THIS DATE.

DISPLAY

Each artist will be assigned a display area 10' wide and 10' deep. Artist must provide their own tent, display and chair. It is every artist's responsibility to their fellow artists to have an adequate as well as a stable display. **Your display may not exceed the assigned space.** Artists may be assigned a new space each year. Special requests will be honored if possible.
