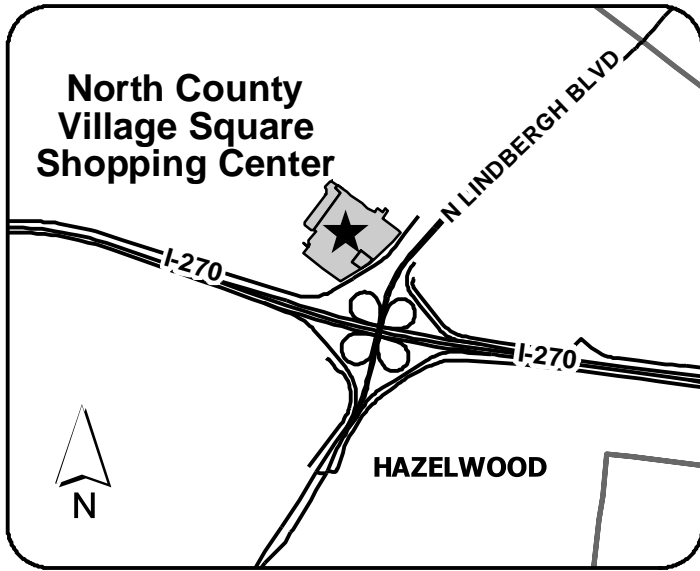


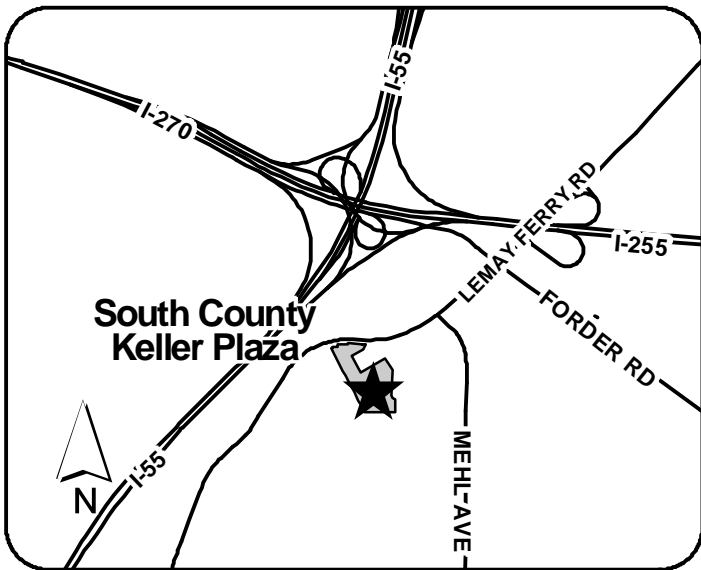

Revenue

- Pay Real and Personal Property Taxes ...check or money order only; no cash
- Obtain real or personal property tax receipts
- Obtain personal property tax waiver
- General tax and billing information ...cannot create or adjust tax bills

Health

- Pay restaurant fees and permits
 - Obtain water testing bottles
- (North & South Centers only)**
- Receive and process waste hauling licenses, demolition applications and solid waste facility applications
 - Receive and respond to complaints regarding storage and handling of trash (not miscellaneous junk and litter)

Human Services

- Services, information and volunteer opportunities for older residents (CORP)
- Information and referrals for veterans
- Services and information for youth

Public Works

- Apply and pay for permits:
 - ✓ Residential and Commercial Building
 - ✓ Electrical, Mechanical and Plumbing
 - ✓ Commercial Re-occupancy and Residential Occupancy
- North & South Centers closed daily for lunch

Neighborhood Preservation
(North & South Centers only)

- Obtain and submit Residential Re-occupancy applications
- File complaints regarding residential properties
- Obtain information on County maintenance and zoning codes

Community Development
(South Center only)

- Obtain information on the Home Improvement Program, based on need, demand and available funds
