BEE TREE **2701 Finestown Road**

Mansion Garden (150 maximum; electric available – group must bring own extension cords)
Garden area located adjacent to Nims Mansion. Does not include access to the Mansion building.

Overlook Memorial (Gazebo; 30 maximum; no electric)
Located on bluffs overlooking Mississippi River.

GENERAL DANIEL BISSELL HOUSE **10225 Bellefontaine Road**

Rose Garden (Gazebo; 80 maximum; No electric)
Your ceremony may be held anywhere within the Rose Garden, which includes the entire southeast quarter of the park. Chairs may **not** be removed from the Bissell Barn.

All vehicles associated with the wedding must park in the southeast parking lot off Bellefontaine Road. No parking is allowed in the circular driveway. Overflow parking is available on the shoulder of Bellefontaine Road.

Wedding pictures may be taken on the grounds, but not inside the Bissell House.

No decorations can be attached to any portion of the Bissell House. All decorations must be removed from the area upon completion of the ceremony.

CREVE COEUR **2348 Creve Coeur Mill Road**

Dripping Springs (80 maximum; no electric)
Located in lower area of park, next to Taco Bell Shelter. Taco Bell Shelter must be reserved with Wedding site to accommodate parking.
