P.P.C.T. DEFENSIVE TACTICS INSTRUCTOR SCHOOL

Unlike many current police subject control systems, The Pressure Point Control Tactics Defensive Tactics System was developed based upon the most common types of physical resistance faced by patrol officers. This is in direct contrast to past training practices of developing techniques based upon every type of resistance. Subject control programs resulting from this training approach often include a multitude of complicated physical movements which cannot be adequately taught in the allotted time, which are often too difficult for the average officer to perform competently, and which are seldom retainable under the stress of actual confrontations. These types of systems often have the reputation of working in the static environment of the gym and not in altercations on the street.

The Defensive Tactics Instructor Program is a 40-hour course designed to give participants' intensive training in the P.P.C.T. program. Each participant will be required to make a 10-minute presentation on one of the techniques and principles of the P.P.C.T. system. After receiving an Instructor Certificate, the student will be able to instruct classes in P.P.C.T. for his/her department.

Training will be hands on and intensive; therefore, it is important that participants be in good physical condition prior to attending this class.

This class will be instructed by Police Officer Tony Spratt, Chesterfield Police Department.
He is an Instructor Trainer for the P.P.C.T. System.

Each student will need handcuffs, duty leather and wrist tape.
